# Providing your consent for JC Professional to be your authorized representative with the CRA

To better help you manage your tax accounts with the Canada Revenue Agency (CRA), please authorize **JC Professional Corporation** as an authorized representative. Previously, taxpayers were able to sign a business consent form and we would be able to take the signed form and complete the set up with the CRA.

Due to increased concerns with identify theft, the CRA has tightened their authorization process requiring further authentication to confirm representatives. The quickest way to grant us authorization is to identify JC Professional Corporation as your authorized representative through your '<u>My Business Account'</u>.

#### What steps do you need to take? Please follow the points outlined below

#### **My Business Account**

- Confirm that you have 'My Business Account' set up; if not, you'll have to <u>register</u> for this first.
- Ensure email notifications have been enabled.
- You'll need to add your business number to your account. You'll only be allowed to do this if your name and social insurance number matches the information the CRA has.

### Authorize JC Professional Corporation as my representative

  - Discuss detailed transactions with CRA on your behalf (such as tracing payments misapplied by CRA, verifying detailed historical tax balances, requesting amendments, and more).
